***Please make sure that you ONLY send your payment for UCR Housing Guest Accommodations to the address below, and ONLY send Bear Facts Orientation fee payments to the Bear Facts Orientation office directly. You cannot pay for both at the same time as these are separate entities.**

Forms without proper payment or missing information will not be accepted. **Payments are non refundable, and make checks payable to "Regents, UC."** You will be sent a confirmation receipt by e-mail regarding your reservation.

Overnight Accommodations

Parents will be staying at a designated Parents building in our Glen Mor Apartments Style housing. There are four (4) single bedrooms per apartment, with 2 bathrooms, a small kitchen and living area. Room rates are at a cost of \$40.00 per person, per night. This amount includes the cost of your overnight stay and overnight parking fees. You will need to bring your own toiletries, hair dryer, and iron (etc...). Television and computer access is not provided in room; however, there is a computer lab open for use within the complex.

Meal Options

Meals are not provided as part of this overnight program; please refer to the Bear Facts Orientation website to find out which meals are included during the parent portion of the orientation program. Breakfast, lunch, and dinner meals may be purchased for an additional fee by cash or credit card at the Lothian Residential Restaurant here on campus.

Waiver of Liability, Assumption of Risk, and Indemnity Agreement**

Waiver: In consideration of being permitted to participate in any way in the Bear Facts Orientation Parent Overnight Housing from _____ to _____ on the University of California, Riverside campus (hereinafter referred to as the “BFO Parent Housing”) I, for myself, my heirs, personal representatives or assigns, **do hereby release, waive, discharge, and covenant not to sue** The Regents of the University of California, its officers, employees, and agents from liability **from any and all claims including the negligence of The Regents of the University of California, its officers, employees and agents**, resulting in personal injury, accidents or illnesses (including death), and property loss arising from, but not limited to, participation in BFO Parent Housing.

Assumption of Risks: Participation in BFO Parent Housing carries with it certain inherent risks that cannot be eliminated regardless of the care taken to avoid injuries. The specific risks vary from one activity to another, but the risks range from 1) minor injuries such as scratches, bruises, and sprains 2) major injuries such as eye injury or loss of sight, joint or back injuries, heart attacks, and concussions 3) catastrophic injuries including paralysis and death.

I have read the previous paragraphs and I know, understand, and appreciate these and other risks that are inherent in the BFO Parent Housing. I hereby assert that my participation is voluntary and that I knowingly assume all such risks.

Indemnification and Hold Harmless: I also agree to INDEMNIFY AND HOLD The Regents of the University of California HARMLESS from any and all claims, actions, suits, procedures, costs, expenses, damages and liabilities, including attorney’s fees brought as a result of my involvement in the BFO Parent Housing and to reimburse them for any such expenses incurred.

Severability: The undersigned further expressly agrees that the foregoing waiver and assumption of risks agreement is intended to be as broad and inclusive as is permitted by the law of the State of California and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

Acknowledgment of Understanding: I have read this waiver of liability, assumption of risk, and indemnity agreement, fully understand its terms, and **understand that I am giving up substantial rights, including my right to sue**. I acknowledge that I am signing the agreement freely and voluntarily, and **intend by my signature to be a complete and unconditional release of all liability** to the greatest extent allowed by law.
